

Video Visitation

All potential visitors must register an account and schedule their visit through InmateSales. Please click on the web link below and follow the instructions. On-site registration is also available on visitation days only. Visitations must be scheduled at least 24 hours in advanced.

Visitation appointments can be scheduled for Saturday and Sunday from 1:00 P.M. to 4:00 P.M. Visitors are allowed two 25-minute visits per weekend. Inmates who are serving time for a short-term Probation Violation are not eligible for visitation.

Inmate Visitation Policy

All visits are subject to change without notice. The Mitchell County Sheriff and Corrections Department reserve the right to revoke or refuse admittance to or end a visit of any individual. Visiting is a privilege and may be denied due to court orders, inmate disciplinary actions, inmate requests or visitor restrictions. Inmates who are security risks will not be allowed to receive visitors.

All rules set forth for video visitation shall be adhered to when using the video visitation system. Any lewd, profane or inappropriate behavior shall result in loss of video visitation privileges for the visitor and/or inmate.

- Video visitation is available on Saturday and Sunday from 1:00 p.m. to 4:00 p.m. Each inmate is allowed two 25-minute visits per weekend.
- Inmates have the right to decline or eliminate a visitation.
- Proper attire is required for both on-site and remote visitation.
 1. All clothing must be clean and in good condition.
 2. Undergarments are required, but should not be visible.
 3. Clothing will be worn as it is designed to be worn.
 4. Shoes must be worn at all times.
 5. No revealing articles of clothing. i.e., shirts must have sleeves, no shorts are allowed, no see-through clothing (lace/sheer/etc.), no low-cut blouses or shirts.
- All visitors must provide proper state or government issued photo identification (i.e., driver's license, foreign id or passports) for inmate visitation.
- Visitation is considered for inmates who are here 48 hours or more. Inmates that are serving a 2–5-day probation violation are not afforded visitation.
- If a visitor is suspected of being under the influence of drugs or alcohol, the visit will be terminated and appropriate actions will be taken.
- Recently released inmates and those on probation will not be allowed to schedule visits.
- Visitation sign-up is limited and on a first-come first serve basis. Visitors are encouraged to go online to reserve a visitation time.
- On-site video visitation is available at no cost. Visitors may only use this system on visitation days. If visitors cannot create an account online, this can be done on-site and must be done prior to scheduling a visit.
- On-site visitors arriving after their scheduled time will not be allowed to visit.
- A legal guardian must accompany all visitors who are 17 years of age and under. Children must be monitored at all times before, during, and after each visit.

- Only two adults or one adult and one minor is allowed to share a visitation during a one 25-minute on-site video visitation.
- You will only communicate with the person you are scheduled to visit with. No exceptions.
- The on-site visitor kiosk will connect with an inmate kiosk. Once the visit has started it will last for 25 minutes. Damage to the video visitation system will result in the loss of visitation privileges and or criminal prosecution. After the 25 minutes have passed the video monitor and handset will shut off. All visitors will exit the video visitation area.
- The following items are not permitted in the video visitation area:
 1. Cell phones (must be turned off)
 2. All tobacco products
 3. Food or drinks of any kind
 4. Cameras (film or video)
 5. Radios (mp3, disc, or tape players)
 6. Drugs, narcotics, or intoxicating beverages
 7. Firearms, weapons, knives, or sharp objects
 8. Inappropriate behavior will result in termination of visit and visitor will be asked to leave the premises.
- No personal contact visits are allowed with inmates.
- Any disruptive or inappropriate behavior by a visitor can result in termination of visitation privileges.
- No congregating permitted inside the video visitation area or outside the entrance to the video visitation area.
- Visitors are subject to a pat-down search prior to entering the visitation area based on jail policies. Any visitor who refuses this search will be denied entry to visit.
- All entering the Mitchell County Law Enforcement Center for visitation are subject to warrant and criminal history checks.
- The Sheriff or Jail Administrator will be the only person authorized to allow special visits.
- All visitations on-site and remote are recorded and are subject to being monitored. By engaging in a visitation, you consent to the recording. The service provider shall not be liable for the unauthorized use or disclosure of recorded visitations.
- Visitors may be asked to terminate the visit and leave the premises at any time at the discretion of the correctional officer. Failure to do so could result in termination of their visitation privilege.
- Visitors are allowed to bring inmates properly marked prescribed medication, prescription glasses, dentures, and special medical equipment (i.e., CPAP machines).
- Inmate property will not be released on visitation day. Arrangements must be made during regular business hours.
- Clergy persons and lawyers may visit inmates anytime as long as it is a reasonable request and doesn't interfere with correction officer's duties.
- **No money will be accepted on visitation day(s).** Cash or money orders (made out to the inmate) will be accepted during regular business hours Monday-Friday (excluding holidays) from 8:00 a.m. to 12:00 p.m. and from 1:00 p.m. to 5:00 p.m. or via mail (PO Box 338, Beloit KS 67420). Checks will not be accepted.

Failure to comply with the visitation policy will result in suspension of visitations for an undetermined amount of time.
